**Convener's Report for SC 24/WG 8
for the
WG 8 and SC 24 Plenary Meetings, Sydney, Australia
26 - 30 August 2013**

WG 8, working in co-operation with the SEDRIS Organization, is responsible for standards relating to the representation and interchange of environmental data. The changes to the WG 8 Standards and work programmes that have occurred over the last year are as follows;

The DIS for ISO/IEC 9973 (Procedures for the registration of items) was approved in November and, since the required changes were minor, a final copy was submitted to ISO for publication. For the final proof that was reviewed by the editors, the only comment related to the format of external URL links. The 3rd Edition of 9973 was published at the end of July.

For ISO/IEC 18025 (EDCS), the FDIS has been prepared and was sent to ISO for balloting in March. The ballot has not yet been posted, however, and the reasons for delay are unclear.

The preparation of the FDIS for ISO/IEC 18026 (SRM) is not a trivial task, since the SRM is a detailed mathematical document. The FDIS is still in preparation, with an original expected completion date of September 2013. However, the progression of the document is subject to the resolution of US DoD budget issues, which will delay the completion date.

The EDCS Registry Rapporteur Group has completed the assessment of 6 submissions, (2007-Q4, 2008-Q1, 2008-Q3, 2009-Q1, 2009-Q3 and 2011-Q1). The 2011-Q1 submitted items may need to be revised, however, due to a change of contractor/proposer. There has been very little work on the Registry over the last year, due to resourcing priorities given to completion of other tasks, including the preparation of the EDCS Edition 2 FDIS.

There have been frequent teleconferences between editors, particularly for the SRM and EDCS standards, but no formal meetings since the 2012 Plenary. WG 8 members have also participated in WG 9 meetings and teleconferences for augmented reality (ARC/MAR).
